The next COLA has been announced and it amounts to \$0.47 per hour for all Table 1 Mail Handlers and top step Table 2 Mail Handlers. The amount of course decreases proportionally for the remaining steps on Table 2 of the pay scales down to a \$0.28/hour increase for Step AA. The COLA takes effect in PP 19 which begins on 8/26.

The Contractual Retro-pay from our CBA being signed will also be coming in PP19/23. You should see an adjustment for the back-pay in your check on 9/15.

Speaking of payments, if you were eligible for the APBS settlement money, you will be receiving that money in this week's paycheck. If you do not receive your settlement, please let me know.
